20-5 Bayer Crop Science – Kansas City, Requesting a variance to change internal inspection intervals from every 1 year to every 2 years.

Motion was made by Gary Rogles to approve the variance. Seconded by Bradley Calvin with the following stipulations:

Any changes to the agreed upon letter without specific consent of the Missouri Boiler and
Pressure Vessel Board will immediately revoke this variance and Bayer shall return to the
annual internal inspections frequency. If Insurance changes the new Insurance Company will
be required to agree to these stipulations.

- 2. The boiler must be inspected by their insurance carrier on a 6 month frequency and a detailed report must be submitted. The report must state that they reviewed their program and it complies with this variance. Our code paragraph 650.260.1 sub paragraph (1) states power boilers and high temperature water boilers shall receive a certificate inspection annually and shall also be externally inspect annually while under pressure if possible.
- 3. Bayer will present all records during this period to the Boiler Board at the June 2022 (actual date to be determined) for a final review. The Boiler Board will then vote and render its decision whether or not to grant a permanent varianc.
