Sprinklers in MRL Elevator Lobbies

Jim Chapman motioned and seconded by Tom Corso the following resolution: Where a controller is located or configured to be maintained, repaired or replaced in an elevator lobby area the lobby area is then considered a control space. Sprinklers located in elevator lobby control space areas shall be provided with a means to automatically disconnect the main power to the affected elevator. This applies to all new installations. Deputy Chief to notify elevator contractors prior to final acceptance of plans and approval of installation permit.
