2018 AFG (Burn Trailer) All equipment received, expended total grant minus approximately \$22,000– Greg Landwehr

2019 AFG (LMS) Next round of licenses are in the process of being billed. After the payment of those licenses we have met the performance requirements of the grant and will be closing it out. We left approximately \$32,000 including our match on the table

2020 AFG (F550 Truck) truck is not in production yet, no expenditures

2021 AFG (Exterior Burn Props and Trailer) applied for, still waiting for the award period to start in August

Workforce Module -Benefits to fire service: Greg Landwehr

Workforce Module presentation by Greg

Becky stated this will add approximately \$20,000 per year to our yearly fee to Acadis Workforce Module – Chris Bird, Western Taney County FPD, user presentation and encourages the commission to find the money to fund this module.

Look at the statutes on collection of fees to help assist with the cost of the Acadis system. Future plans to utilize the workforce portal along with the Organization Certification to replace the current Fire Department registration process
